#### **Booking your exams**

You must book your GESE exams through Trinity's new exam administration web portal (full instructions are available from your co-ordinator). Do remember that you can now make changes to your order yourself, right up until the night before the exams.

### Open exam sessions in Ireland

We are no longer offering open exam sessions during the summer. However, to provide greater flexibility and accommodate smaller groups, we have reduced our minimum fee period to a half day (3 hour) session.

#### Certificates

Certificates are issued six to eight weeks after the exam session and sent to centres for distribution.

# **Guidance and support for teachers**

#### Short course guide

#### Resources

GESE support materials and resources, including example lesson plans and sample exam videos are available online. For centres new to delivering GESE, especially those running PON-funded programmes, please contact **Janet Golding** to request a free support session for teaching staff. This 60 minute session can take place during your senior staff induction programme, or during a GESE course. This offer is dependent on Janet's availability, so book quickly!

#### **Code of Practice**

As part of our quality assurance programme, Trinity carries out inspection visits to centres and, as a registered exam centre, it is imperative that our Code of Practice is adhered to at all times.

Please ensure that every member of staff involved with Trinity exams is aware of these requirements prior to the start of the session.

# Monitoring of examiners

The performance of our examiners is periodically observed by an Inspection Monitor.

If your Trinity examiner is due to be monitored, we will inform you before the exam session. concerns through a weekly appointment system.

We also plan to offer webinars on preparing candidates, which will be delivered during peak season and be dependent on sufficient interest.

## Become a Trinity test trial centre

We are currently inviting centres to take part in test trialling sessions, which help Trinity ensure that exam questions are set at the correct level. Taking part is free for learningcentres and gives your students the opportunity to practise under live exam conditions.

The next available sessions will be for ISE, which run from July to September. If you would like to participate, please send us an email specifying a preferred date and how many students you have at each level. We will be in touch to let you know how to organise the session. Please bear in mind that although we are trialling ISE speaking and listening components, we are happy for students studying for GESE to participate.

We are also offering an opportunity to trial a short English language test this year that we are using as an internal research tool. Although it is not a Trinity test, it is perfect for a classroom test - it takes about 30 minutes and results are indicated by the percentage of correctly answered questions. If you are interested this, please email us and we will schedule a date for the test.
