TERMS OF USE

1. About the Terms of Use

These Terms of Use, together with the <u>privacy statement for our websites</u>, set out the terms on which you may make use of the Trinity Teacher Directory (the "**Directory**") provided by Trinity College London Press Limited ("**Trinity**", "**us**" or "**we**"), whether as a guest or as a registered user. By using the Directory and/or any of the services available through it, you agree to be legally bound by, and comply with, these Terms of Use. We recommend that you read these Terms of Use and the <u>privacy statement for our websites</u> carefully before you start to use the Directory and keep a paper/electronic copy for your records. If you do not accept these Terms of Use or the <u>privacy statement for our websites</u>, please refrain from accessing or using the Directory.

We reserve the right to update these Terms of Use at any time. If we do so, we will publish the amended version here. Every time you wish to use the Directory, please check these Terms of Use to ensure you are aware of the terms that apply at the time of your use. The amended Terms of Use will take effect from the time they are first published in the Directory and, from then on, will govern the relationship between you and us in respect of your use of the Directory. These teachers are not agents, partners or employees of Trinity or any of its group companies, nor have they been vetted or endorsed by Trinity. Please conduct your own checks before entering into any arrangement with a teacher. Any contractual, financial or other arrangements that are entered into with a teacher will be directly with such teacher and not with Trinity. We are not liable for any act or failure to act by any person listed on the Directory. Any enquiries or disputes with a teacher should be dealt directly with the relevant teacher.

The Directory is directed at people residing in the United Kingdom. We do not represent that content available in or through the Directory is appropriate for use or available in other locations. We also make no representations, warranties or guarantees, whether express or implied, that the content in the Directory is accurate, complete or up to date. Any of the material or content in the Directory may be out of date at any given time, and we are under no obligation to update such material.

We may update and change the Directory and any goods or services available from the Directory webpages from time to time. We do not guarantee that the Directory, or any content on it or goods or services offered through it, will always be available or be uninterrupted. We may suspend or withdraw or restrict the availability of all or any part of the Directory and/or its goods or services for business, operational or regulatory reasons.

4. Your use of the Directory

You must be 18 years or older in order to contact a teacher via the Directory. If you are under 18 years of age, you should ask your parent or legal guardian to email the teacher on your behalf. The teacher will have sight of the email address that you use to email them as well as any other information (including personal information) that you include in the email. Trinity will not have access to your mail address or to this information.

To create a listing or profile in the Directory or to access and/or enter certain content into the Directory, you must be at least 18 years old, have no criminal convictions and must register with us and create an account. We retain the right to determine at our own discretion whether or not you may create and maintain an account with us. Creation of an account in the Directory is free of charge. To do so you will need to give us certain personal information requested on the registration page which we will collect and use in accordance with the <u>privacy statement for our websites</u>. Once viewed by us and found to be in order, your profile will confirm that your DBS Check has been evidenced, and you must keep your DBS Check renewed and up-to-date and inform us immediately if your DBS Check lapses, if the status of your DBS Check changes or if you incur a criminal conviction. We may change the status of your DBS Check on your profile in accordance with such information. We retain the right to re-confirm the information that you provide to us from time to time, including to confirm that the status of your DBS Check remains unchanged. We also retain the right to request you to provide us with copies of your future updated DBS Checks. We will delete and will not retain the copy of your DBS Check once we have confirmed that it is in date and that you have no prior criminal convictions. Where you choose not to provide the DBS Check to us or withdraw your consent, your profile will confirm that no DBS Check has been evidenced.

Please note that the information you provide to be uploaded to your profile, including personal information, will be available to the general public to access and use and will be considered non-proprietary and non-confidential. You must ensure that the personal information you provide when you register is correct and complete and update your account immediately with any changes to that personal information. You can access and update the information you provide to us by accessing your account in the Directory. You can also choose to pause or delete your listing at any time. Deletion of your listing does not delete your account with Trinity (which may be used to access other services offered by Trinity and its group companies). If you wish to delete your account then contact teacherdirectory@trinitycollege.com. You must only register for one user account as registering for multiple accounts is not allowed. Sharing accounts is also not allowed. You may only upload one static image to your account and animated images or gifs are not allowed.

You must choose and use a set of unique log-in credentials ("Credentials") for the Directory. You will be required to enter your Credentials each time you wish to access your account. You must keep your Credentials confidential and secure and must not share them with any third party. You may not share your Credentials with anyone and you are responsible for all activities that are carried out under them. We do not check the identities of people using the Directory and will not be liable where your Credentials are used by someone else. You agree to notify us immediately by email to teacherdirectory@trinitycollege.com of any unauthorised use of your Credentials or account of which you become aware or if you know or suspect that anyone other than you has come to know your Credentials. 5. Your use of content in the Directory

If you print off, copy, download, share or repost any part of the Directory in breach of these Terms of Use, your right to use the Directory will cease immediately and you must, at our option, return or destroy any copies of the materials you have made.

6. Uploading content to the Directory

- a) any loss of profits, revenue, loss of business opportunities, loss of savings, depletion of goodwill and/or similar losses, or pure economic loss or any loss or corruption of data (excluding any personal data) or information (regardless of whether these types of loss or damage are direct, indirect or consequential); or
- b) any special, indirect or consequential loss or damage whatsoever,

in each case however arising under or in connection with these Terms of Use and even where the parties were aware of the possibility that such loss or damage might be incurred.

Subject to the preceding two paragraphs, Trinity's total aggregate liability arising under or in relation to these Terms of Use, including liability for breach of contract, misrepresentation (whether tortious or statutory), tort (including negligence) and breach of statutory duty shall not exceed £2,000.

To the maximum extent permitted under applicable law, we exclude all express or implied conditions, warranties, representations or endorsements whatsoever with regard to any content, information, material, software or other items or services provided through the Directory including those as to availability, quality, timeliness, performance, or fitness for a particular purpose.

We shall not be liable for any loss or damage resulting from the illegal, incorrect or inappropriate use of any content, information, material, software or other item by you or anyone else whilst the content is in your possession.

We will always tell you in writing if this happens and we will ensure that the transfer will not affect your rights under the contract. These Terms of Use are personal to you and entered into by you for your own benefit and not for the benefit of any third party.

These Terms of Use are governed by and are to be construed in accordance with English law. This means that any dispute or claim arising out of or in connection with them will be governed by English law. You and we both agree to the exclusive jurisdiction of the courts of England and Wales.
